**AN ORDINANCE DECLARING
CERTAIN VILLAGE PROPERTY TO
BE SURPLUS AND PROVIDING FOR
THE SALE BY PUBLIC AUCTION**

WHEREAS, it has been determined according to the state statutes and Village ordinances by the corporate authorities of the Village of Vernon Hills that there exists certain surplus property, and

WHEREAS, the corporate authorities desire to sell such surplus property by public auction, and

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois as follows:

SECTION I.

The following property the Village of Vernon Hills is found and declared to surplus namely:

1. Miscellaneous found items and obsolete or outdated Police Department equipment registered with the Property Room.com:

SECTION II. The said surplus items and equipment are to be sold at public auction and the Chief of Police is hereby directed to plan and supervise the delivery of the surplus items and equipment to the auction.

SECTION III. The said surplus items and equipment listed in Section I shall not have a minimum bid.

SECTION IV. SEVERABILITY In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications that are severable, the valid applications shall remain in effect.

SECTION V. REPEAL AND SAVINGS CLAUSE All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION VI. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

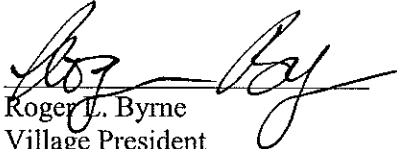

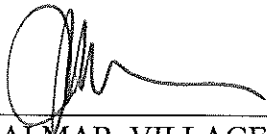
