

RESOLUTION 2015-042

**A RESOLUTION GRANTING APPROVAL TO OPERATE AN
OUTDOOR SPECIAL EVENT FOR FANTASY AMUSEMENT COMPANY
LOCATED AT 122 HAWTHORN CENTER**

WHEREAS, William Johnson, representing Fantasy Amusement Company on behalf of Westfield Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate a special event; and

WHEREAS, the property, as described herein is located within the B-1, General Business District; and

WHEREAS, Section 13.7.6 of the Zoning Code authorizes the Village Board to approve outdoor uses within the B-1 General Business District; and.

WHEREAS, the Board of Trustees, at their Committee of the Whole meeting on March 17, 2015 having reviewed and considered the request for an outdoor special event, found that the application and plan sufficiently comply with Section 13.7.6 of the Zoning Code and which, in its judgment, would justify it in recommending approval of the Outdoor Special Event.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Fantasy Amusement Company to operate an outdoor special event, conditioned upon:

1. The special event will take place from Thursday, June 11, 2015 through Sunday, June 14 2015.
2. The permitted hours of operation shall be: Thursday 6:00 pm – 10:00 pm; Friday 6:00 pm – 11:00 pm; Saturday 2:00 pm – 11:00 pm; and Sunday 2:00 pm – 10:00 pm.
3. The Village reserves the right to close off portions of Ring Road for the purpose of creating a pedestrian crossing.
4. Fantasy Amusement Company is required to submit a list of all employees working at the carnival to the Vernon Hills Police Department at least seven (7) days in advance of the event.
5. Fantasy Amusement Company is required to hire two (2) off duty Vernon Hills police officers to be on site during the operating hours of the carnival. Fantasy Amusement Company shall be responsible to pay the cost of the officers at a rate determined by the village.
6. Compliance with the application and site plan dated February 13, 2015.

7. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event.




