

RESOLUTION 2015-057

A RESOLUTION AWARDING THE FURNISH AND DELIVER FUEL BID TO MANSFIELD OIL COMPANY FOR THE PURCHASE OF GASOLINE AND DIESEL FUEL FOR A TWO YEAR PERIOD FROM 2015-2017

WHEREAS, the Village of Vernon Hills Public Works Department budgeted \$205,950 for the purchase of gasoline and diesel fuel in account (0102040-530140) for the 2015-16 budget year; and

WHEREAS, Community School District #128, Cook Memorial Library, Countryside Fire Protection District, and the MEG Unit all purchase fuel from the Village; and each user reimburses an additional \$.08 surcharge per gallon of usage each month; and

WHEREAS, bids for the purchase and delivery of fuel from 2015-2017 were opened on March 27, 2015 and received from Mansfield Oil Company (Gainesville, GA), Avalon Petroleum (Kankakee, IL), Petroleum Traders Corporation (Ft. Wayne, IN), Gas Depot Inc (Morton Grove, IL), and Olson Service Company (Fox Lake, IL.); and

WHEREAS, the lowest bid was submitted by Mansfield Oil Company; and

WHEREAS, providing Mansfield Oil Company meets the Village's insurance requirements, they will be determined to be the best-qualified bidder to provide gasoline and diesel fuel for the two year period.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the contract be awarded to Mansfield Oil Company for the purchase of gasoline and diesel fuel for a two year period beginning May 1, 2015 and ending April 30, 2017; and

THAT, the Village Manager is authorized to execute a contract and commit the Village to make payments to Mansfield Oil Company; and

THAT, the Finance Director is authorized to execute a purchase order to Mansfield Oil Company for FY2015-16 and FY2016-17; and

THAT, the Finance Director is authorized to increase the FY2015-16 and FY2016-17 purchase orders to Petroleum Traders Corp. with monies reimbursed by outside users.




