

RESOLUTION 2015-087

A RESOLUTION AMENDING RESOLUTION 2015-014 AUTHORIZING AN INCREASE IN PAYMENT  
TO BALANCED ENVIRONMENTS, INC. FOR WORK PERFORMED  
UNDER THE 2014 ARBOR THEATER LANDSCAPE MAINTENANCE CONTRACT  
FROM \$29,711 TO \$36,000

WHEREAS, the Public Works Department delineated \$34,000 in the FY2014-15 budget account (0102081-520600) for landscape maintenance at the Arbortheater to include general mowing, weeding, and pruning; and

WHEREAS, Resolution 2014-035 awarded Balanced Environments, Inc. the 2014 Landscape Maintenance contract for the Arbortheater in an amount not to exceed \$25,000; and

WHEREAS, Resolution 2015-014 authorized an increase in payment from \$25,000 to \$29,711 to Balanced Environments, Inc. for dormant pruning work performed beyond Balanced Environment's original scope of work; and

WHEREAS, staff has also determined it necessary during spring to clear-cut the over-grown brush along the SW side of the Arbortheater property to promote healthy new growth and provide an aesthetically pleasing environment for residents visiting the site; and

WHEREAS, staff is requesting an amendment to Resolution 2015-014 and an increase to purchase order #674 to provide additional payment to Balanced Environments, Inc. in the amount of \$6,289 for said clear-cutting work; and

WHEREAS, the additional \$6,289 is currently available within the FY2014-15 account (0102081-520600) where no budget transfer or increase will be necessary.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS;

THAT, the Finance Director is authorized to increase payment to Balanced Environments, Inc. for work performed under the 2014 Arbortheater Landscape Maintenance Contract from \$29,711 to \$36,000; and

THAT, the Finance Director is authorized to increase FY2014-15 purchase order # 674 in the amount of \$6,289 with funds taken from FY2014-15 account (0102081-520600).




