

**VILLAGE OF VERNON HILLS
ORDINANCE NO. 2018-006**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$20,000 TO
MORTON SALT INC. TO FURNISH BULK ROCK SALT UNDER THE SECOND YEAR OF
THE LAKE COUNTY JOINT BID FOR AN AMOUNT NOT TO EXCEED \$78,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is under its second year of the Lake County joint bid for the purchase of 800 tons of Bulk Road Salt at a rate of \$62.15 per ton for the 2017-18 Winter season with Morton Salt Inc.; and

WHEREAS, the Village has the ability to purchase a minimum of 80% (640 tons) or up to 120% (960 tons) of 800 tons contracted under the Lake County Bid by November 1, 2018; and

WHEREAS, if additional salt is needed beyond 960 tons, the Village may have the ability within the contract to secure up to an additional 240 tons which is equivalent to 150% of the contracted 800 tons for a price of \$67.15 per ton; and

WHEREAS, the Village Board approved the FY2017-18 budget which delineates funds for the purchase of said salt; and

WHEREAS, the consolidated purchases throughout the budget year of over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: THAT, the Finance Director is authorized to execute payments to Morton Salt Inc. for the purchase of up to 1200 tons of Bulk Road Salt for an amount not to exceed \$78,000.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-006.
