

**ORDINANCE 2018 - 034**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE VILLAGE OF VERNON HILLS, CHAPTER 25, SECTION 25-23, ADOPTING BY REFERENCE OF THE VERNON HILLS OVERNIGHT PARKING PERMIT AND USER FEE POLICY**

**WHEREAS**, the Village of Vernon Hills regulates parking on roadways within the Village between the hours of 2am-6am; and

**WHEREAS**, the Police Department receives requests regarding the inconvenience caused by the Village's overnight parking restriction on families with multiple automobiles, especially during holiday and summer breaks when college students are temporarily residing at a home; and

**WHEREAS**, there is currently an "overnight parking permit" process in place, but it restricts overnight parking to certain neighborhoods of multifamily dwellings with limited parking areas; and

**WHEREAS**, the Village Board, at its meeting of February 20, 2018, directed staff to prepare an ordinance creating the Overnight Parking Permit and User Fee Policy; and

**WHEREAS**, the Policy authorizes the creation of Extended Overnight Parking Permission Permits, establishes the permits shall be for 30, 60, or 100 days, and the permit fees which cost \$50, \$75, and \$100 respectively; and

**WHEREAS**, the Police Department will report back to the Village Board in the future regarding the effectiveness of this program; and

**WHEREAS**, this permit process will expire on March 31, 2019 unless otherwise modified or extended; and

**WHEREAS**, the user fees require codification in Chapter 25, Section 25-23 Traffic and Motor Vehicles of the Vernon Hills Code of Ordinances to reflect fees consistent with the Vernon Hills Overnight Parking Permit and User Fee Policy.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION I:** That there is hereby adopted by reference, as if fully set out herein, the Vernon Hills Overnight Parking Permit and User Fee Policy.

**SECTION II:** That Chapter 25 of the Vernon Hills Code of Ordinances, amending Section 25-23 is hereby amended to add the following fee schedule for Overnight Parking Permit User Fees.

Overnight Parking Permit and User Fee Policy

PERMITS ISSUED FOR	FEE
30 days	\$ 50
60 days	\$ 75
100 days	\$100

**SECTION III:** That in the event that the rules, regulations, terms or conditions imposed pursuant to the Vernon Hills Overnight Parking Permit and User Fee Policy are either more restrictive or less restrictive than comparable rules, regulations, terms or conditions imposed by any other applicable rule, regulation, resolution, ordinance, statute or law, then the most restrictive rules, regulations, terms or conditions shall govern.

**SECTION IV:** That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

**SECTION V:** That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form, as provided by law.


**SECTION VI:** This Ordinance shall be known as Ordinance Number 2018-034.


