

**VILLAGE OF VERNON HILLS
ORDINANCE NO. 2018-038**

AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS FOR CONTRACTUAL STREET SWEEPING SERVICES AND AUTHORIZING THE EXECUTION OF A SECOND YEAR RENEWAL CONTRACT BETWEEN THE VILLAGE OF VERNON HILLS AND TKG ENVIRONMENTAL SERVICES GROUP, LLC FOR AN AMOUNT NOT TO EXCEED \$53,226.45

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village budgeted funds within FY2018-19 budget account (0102040-520630) for contractual power sweeping of Village streets; and

WHEREAS, Ordinance 2017-046 was approved authorizing the Village to execute a contract with TKG Environmental Services Group, LLC for said services within FY2017-18; with the option to renew the contract up to two additional years; and

WHEREAS, TKG Environmental Services Group, LLC had provided the Village with supplemental sweeping services for several years prior, and staff has been pleased with their performance during the first year of their full service contract; and

WHEREAS, staff recommends waiving the competitive bidding process for contractual street sweeping services; and executing a second year renewal contract with TKG Environmental Services Group, LLC for an amount not to exceed \$53,226.45; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for contractual street sweeping of Village streets with TKG Environmental Services Group, LLC at a price not to exceed \$53,226.45 within the 2018-19 Fiscal Year.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to TKG Environmental Services Group, LLC in an amount not to exceed \$53,226.45 within the 2018-19 Fiscal Year.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-038.


