

**AN ORDINANCE A CAREER DEVELOPMENT PAYMENT IN THE AMOUNT OF \$2,255**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Section 8.23 of the Village Personnel Rules provides for payments to employees pursuant to the Career Development Plan; and

**WHEREAS**, a payment due in June 2016, listed in Exhibit A, was not previously made to a former employee; and

**WHEREAS**, the Village Board now desires to issue a payment in the amount of \$2,225 for Career Development.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2018-069.


