

**AN ORDINANCE AWARDING THE 2018 BITUMINOUS OVERLAY PROJECT TO
BUILDERS PAVING LLC FOR AN AMOUNT NOT TO EXCEED \$207,890**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the President and Board of Trustees approved a budget of \$500,000 within budget account (0309109-550050) to address various roadway improvements; and

WHEREAS, the Motor Fuel Tax Funds for 2018 are allocated for a Road Rehabilitation program and a Bituminous Overlay project; and

WHEREAS, the Bituminous Overlay work will be performed within the Gregg's Landing Commercial Site on Gregg's Parkway and within the Vernon Hills Athletic Complex 6A parking lot; and

WHEREAS, the 2018 Bituminous Overlay plans were publicly bid and opened on April 18, 2018 with Builders Paving LLC of Hillside, Illinois, submitting the lowest qualifying bid of \$207,890; and

WHEREAS, an Ordinance is required for the award of bids and/or contracts.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to award the contract to Builders Paving LLC for the 2018 Bituminous Overlay Project.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Builders Paving LLC for an amount not to exceed \$207,890 within the 2018-19 Fiscal Year for the 2018 Bituminous Overlay Project.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-084.


