

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO TYLER TECHNOLOGIES FOR THE PURCHASE OF MUNIS MAINTENANCE SERVICES FOR FISCAL YEAR 2018 – 2019 IN AN AMOUNT NOT TO EXCEED \$54,550

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village uses financial software to record revenue and expenditure transactions, issues payments to its employees and vendors, and issue permits; and

WHEREAS, the Village has determined that Tyler Technologies’ Munis software is a cost effective sole source provider of financial software; and

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to purchase maintenance services for Fiscal Year 2018 – 2019 from Tyler Technologies in an amount not to exceed \$54,550.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Tyler Technologies in an amount not to exceed \$54,550 and is further authorized to immediately release payment to Tyler Technologies for Fiscal Year 2018 – 2019 maintenance services prior to appearing on the invoice approval list.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-074.
