**AN ORDINANCE AUTHORIZING THE GENERAL FUND TO TRANSFER \$1,141,158 TO
THE DISPATCH CENTER FUND FROM THE POLICE TELECOMMUNICATIONS BUDGET
TO COVER THE COSTS OF FISCAL YEAR 2018 – 2019 DISPATCH SERVICES
FOR VERNON HILLS**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Budget Ordinance 2018-071 authorized the transfer of \$1,141,158 from the General Fund to the Dispatch Center Fund to cover the cost of the Fiscal Year 2018 – 2019 dispatch services for the Village of Vernon Hills; and

WHEREAS, this amount is projected to be the General Fund’s contribution required to cover dispatch service costs after the application of all E-911 receipts and dispatch customer receipts to the costs of the Dispatch Center; and

WHEREAS, expenditures over \$20,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF
TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to transfer \$1,141,158 from the Police Telecommunications Transfer to Dispatch Fund account (0103032-580080) to cover the costs of the Fiscal Year 2018 – 2019 dispatch services for the Village of Vernon Hills.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-076.
