ORDINANCE NO. 2018-094

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$25,000 TO GAS DEPOT OIL COMPANY FOR THE PURCHASE OF GASOLINE AND DIESEL FUEL, AND AUTHORIZING PAYMENT FOR SAID SERVICES FOR AN AMOUNT NOT TO EXCEED \$222,000 WITHIN FISCAL YEAR 2018-19

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village purchases fuel for use in its fleet from a fuel supplier; and

WHEREAS, Community School District #128, Cook Memorial Library, Countryside Fire Protection District, and the MEG Unit also utilize the Village's supply of fuel; and each user reimburses the Village an \$.08 surcharge per gallon of usage each month; and

WHEREAS, the Village is currently entering into its second year of the awarded two year contract with Gas Depot Oil Company for the purchase of gasoline at the OPIS daily average price minus \$0.0350 per gallon plus applicable fees and taxes; and the OPIS daily average price plus \$0.000 per gallon plus applicable fees and taxes for diesel fuel; and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Gas Depot Oil Company in an amount not to exceed \$222,000 within the 2018-19 Fiscal Year for the purchase of fuel; and

The Finance Director is authorized to increase the purchase order to Gas Depot Oil Company, as needed, with monies reimbursed by outside users.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-094.




