AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO CRYSTAL MAINTENANCE SERVICES, CORP. FOR JANITORIAL SERVICES AT THE PUBLIC WORKS FACILITY, ARBOR THEATER, METRA STATION, VILLAGE HALL, POLICE DEPARTMENT, COMMUNICATIONS FACILITY, AND MUNI GOLF COURSE, AND AUTHORIZING PAYMENT FOR SAID SERVICES FOR AN AMOUNT NOT TO EXCEED \$68,580 WITHIN FISCAL YEAR 2018-19

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills currently has seven (7) facilities that require contracted janitorial cleaning services; and

WHEREAS, the Village is entering into its second year of a three year contract with Crystal Maintenance Services, Corp. for said services with no increase in monthly service costs; and

WHEREAS, an additional \$3,000 has been allocated, and is available, within the FY2018-19 budget for any additional cleaning requests out of the normal monthly scope of work; and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments not to exceed \$68,580 to Crystal Maintenance Services, Corp. within the 2018-19 Fiscal Year for contractual janitorial cleaning services; and

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2018-095.


