**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$25,000 TO CONSTELLATION NEWENERGY, INC. FOR ELECTRICAL SERVICE FOR STREET LIGHTING WITHIN THE FY2018-19 BUDGET YEAR NOT TO EXCEED \$80,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village Board approved the FY2018-19 budget that delineates expenditures for electricity usage for street lighting in account (0102040-520050) for the following:

Master Account -38039:	37 Montauk Ln 75 RT 45 Lite RT/25, Dusk to Dawn 0 E Lakeview Lite RT/25
Master Account -56032	0 S RT45, Butterfield Rd.
Woodbine @ Milwaukee Ave.:	0 SW Milwaukee Ave Lite- Woodbine

**WHEREAS**, the Village has signed a multi-year contract through June of 2020 with Constellation Newenergy, Inc. as an alternate energy provider for the Village's street lighting; and

**WHEREAS**, all expenditures and purchases over \$25,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** THAT, the Finance Director is authorized to execute payments to Constellation NewEnergy, Inc. for electrical service for street lighting throughout the FY2018-19 budget year in an amount not to exceed \$80,000.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2018-089.


