

**ORDINANCE 2018-115**

**AN ORDINANCE AMENDING ORDINANCE 2018-073 AUTHORIZING APPROVAL OF A \$100,000 INCREASE IN PAYMENT FOR CERTAIN LEGAL SERVICES FOR FISCAL YEAR 2018 - 2019**

**WHEREAS**, all professional service engagements that require the expenditure of over \$25,000, require Board of Trustees approval; and

**WHEREAS**, in Ordinance 2018-073, the Village Board authorized payment to Hunt & Associates for legal services for labor issues not to exceed \$50,000; and

**WHEREAS**, due to the need for additional legal services, it is required to increase the limit to \$150,000 for Hunt & Associates.

**NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**THAT**, the Village Manager is authorized to execute payments to Hunt & Associates in an amount not to exceed \$150,000.
