



ORDINANCE NO. 2018-119**

**AN ORDINANCE APPROVING A THREE-YEAR AGREEMENT  
WITH SOCCER EVENTS GROUP, LLC AT  
THE VERNON HILLS ATHLETIC COMPLEX**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Vernon Hills Athletic Complex (VHAC) is comprised of multiple parties with Federal lease agreements related to the parcels including Community High School District 128, Stevenson High School District 125, Lincolnshire-Prairie View School District 103 and the Village; and

**WHEREAS**, the Soccer Events Group, LLC (SEG) desires to enter into an agreement to provide for the use of Village, American Hotel Register and School District-leased parcels for soccer tournaments in 2018, 2019 and 2020; and

**WHEREAS**, the Village and Lincolnshire-Prairie View School District 103 have a user agreement that permits the Village to hold various events on School District 103's property; and

**WHEREAS**, SEG has or will obtain approvals for the use of all proposed fields; and

**WHEREAS**, SEG understands that Vernon Hills High School home games exist in 2019 and 2020 and will modify the locations and game times to address any potential concerns; and

**WHEREAS**, SEG has agreed to pay a fee of \$25,000 for both soccer tournaments and increased their role in items such as the obtaining and financing of the port-a-lets; and

**WHEREAS**, SEG has executed the attached agreement (Exhibit A) and approval of this ordinance signifies the Village Board's support of the tournament and agreement.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute said agreement with the Soccer Events Group, LLC.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2018-119.




