**A RESOLUTION APPROVING A RAFFLE LICENSE AND

WHEREAS, Chapter 18, Article II, Section 18-39 of the Village's Code of Ordinances authorizes the Village Board to approve raffle licenses; and

WHEREAS, the Board of Trustees, at its meeting on September 5, 2018 reviewed and considered the application for raffles, found that the application sufficiently complies with the requirements of Chapter 18, Raffles and, in its judgment, would justify recommending approval of the raffle license.
