

ORDINANCE 2018-133

AN ORDINANCE APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF VERNON HILLS AND VILLAGE OF LINCOLNSHIRE FOR THE PROVISION OF POLICE DISPATCH SERVICES

WHEREAS, the Village of Vernon Hills is a Municipal Corporation of the State of Illinois and the Village of Lincolnshire is a Municipal Corporation of the State of Illinois, all situated in Lake County, Illinois and authorized and empowered to enter into this agreement; and

WHEREAS, the Constitution of the State of Illinois, 1970, Article VII, Section 10, authorizes agencies of local government to contract or otherwise associate among themselves in any manner not prohibited by law or ordinance; and

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1, provides that any one or more public agencies may contract with any one or more public agencies to perform any governmental service, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform, provided that such contract shall be authorized by the governing body of each party to the agreement; and

WHEREAS, the Village of Vernon Hills and Countryside Fire Protection District (hereinafter Communication Center) jointly operate a communication center for dispatch services; and

WHEREAS, the Village of Vernon Hills currently has a contract to provide dispatch services with the Village of Lincolnshire which expires on September 30, 2018; and

WHEREAS, the Village of Vernon Hills wishes to enter into an agreement extending the current agreement into the future at updated rates pursuant to which the Communication Center will provide Lincolnshire with certain emergency telephone answering, police and radio dispatch services utilizing personnel and equipment maintained and operated by the Communication Center.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS UNDER THEIR HOME RULE AUTHORITY:

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.




