ORDINANCE NO. 2018-151

AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO JAMES MARTIN AND ASSOCIATES TO PERFORM SNOW & ICE CONTROL SERVICES FOR CUL-DE-SACS AND THE METRA STATION DURING THE 2018-19 WINTER SEASON IN AN AMOUNT NOT TO EXCEED \$116,500

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (“the Village”) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village budgeted funds within the street contractual services account (0102040-520630), and the Metra street contractual services account (090985-520630) for the snow removal of streets, cul-de-sacs, and sidewalks within the 2018-19 Fiscal Budget Year; and

WHEREAS, the Village is in a multi-year contract with James Martin and Associates for contractual snow removal services of 108 cul-de-sacs and the Metra Station from 2017-18 and extending through Winter 2019-20; and

WHEREAS, the following is the fee schedule for the 2018-19 services; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to James Martin and Associates for snow & ice removal services for the 2018-19 Winter season in an amount not to exceed \$116,500 (\$36,500 Metra & \$80,000 Cul-de-sacs).

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2018-151.


