ORDINANCE 2019-032

AN ORDINANCE AUTHORIZING APPROVAL OF A CONTRACT WITH CIVILTECH ENGINEERING FOR AN AMOUNT NOT TO EXCEED \$453,389

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for the maintenance of its infrastructure; and

WHEREAS, the Village has identified the need for improvements to Lakeview Parkway from Center Drive to Fairway Drive; and

WHEREAS, the Lake County Council of Mayor’s has included this project on their approved list for Federal funding; and

WHEREAS, the Village budgeted \$474,000 in FY18-19 for Phase 2 Engineering Services of which 80 percent is reimbursable; and

WHEREAS, the Federal funding requires a Qualification Based Selection process whereby Civiltech Engineering was selected; and

WHEREAS, Civiltech Engineering, Inc. has submitted a contract and price proposal acceptable to the Village Board subject to our Village Attorney’s approval; and

WHEREAS, consolidated purchases throughout the budget year of over \$20,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for the Lakeview Phase 2 Professional Services with Civiltech Engineering, Inc. at a cost not to exceed \$453,389 subject to the Village Attorney’s approval of said documents.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Civiltech Engineering, Inc. in an amount not to exceed \$453,389; and

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2019-032.




