**ORDINANCE NO. 2019-034**

**AN ORDINANCE AUTHORIZING APPROVAL A PAYMENT TO ADVANCED BUSINESS NETWORKS FOR INFORMATION TECHNOLOGY SUPPORT FOR FISCAL YEAR 2018-2019 AND FY2019-20 IN AN AMOUNT NOT TO EXCEED \$36,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village uses Advanced Business Networks for its information technology support; and

**WHEREAS**, the Village's FY2018-19 budget anticipated a cost of \$84,000 for these services; and

**WHEREAS**, last May a \$48,000 payment was made to Advanced Business Network for FY2018-19 pursuant to the authorization obtained through Ordinance Number 2018-81; and

**WHEREAS**, it is anticipated that the cost for these services in FY2018-19 will be \$66,000; and

**WHEREAS**, Advanced Business Networks offers blocks of over three hundred hours of Information Technology support at a 20% discount; and

**WHEREAS**, three hundred hours of support time costs \$36,000 for Village-wide information technology support; and

**WHEREAS**, \$18,000 of that amount shall be applied to FY2018-19 and \$18,000 will be a Prepayment of services to be received in FY2019-20; and

**WHEREAS**, expenditures over \$20,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Advanced Business Networks in an amount not to exceed \$36,000 for information technology support for Fiscal Year 2018-2019 and FY2019-20 and authorized to immediately release payment to Advanced Business Networks for information technology support prior to appearing on the invoice approval list.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2019-034.


