**ORDINANCE 2019-030**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO CURRIE MOTORS FOR THE PURCHASE OF ONE (1) 2019 FORD ESCAPE IN THE AMOUNT OF \$21,190.00**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, funds are delineated in FY18/19 budget account (2102066-540030) for vehicle purchases; and

**WHEREAS**, cash reserves exist in the Replacement Fund for the purchase of a Community Development vehicle replacement; and

**WHEREAS**, Currie Motors, 10125W Laraway, Frankfort, IL 60423 is an authorized Ford dealership that has been selected through a competitive bidding process to provide motor vehicles to municipalities participating in the Northwest Municipal Conference Suburban Purchasing Cooperative Contract #165 at the rate specified in the bid (contract); and

**WHEREAS**, all purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Currie Motors to commit the Village to purchase one (1) 2019 Ford Escape in the amount of \$21,190.00; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Currie Motors in the amount of \$21,190.00; and

**SECTION 3: AUTHORIZATION TO INCREASE BUDGET:** The Finance Director is authorized to increase the Replacement Fund budget for account 2102066-540030 by \$21,190 using accumulated reserves includes insurance reimbursement; and

**SECTION 4: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 5: ORDINANCE NUMBER:** This ordinance shall be known as ORDINANCE NUMBER 2019-030.




