**ORDINANCE 2019-041**

**AN ORDINANCE AMENDING ORDINANCE 2018-131 AUTHORIZING AN INCREASE IN EXPENDITURES TO MORTON SALT INC. FOR THE PURCHASE OF 1,600 TONS OF BULK ROAD SALT IN AN AMOUNT NOT TO EXCEED \$104,000 FOR THE 2018/2019 WINTER SEASON**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Public Works Department has budgeted funds for the purchase of bulk road salt in the FY2018-19 Street Maintenance Supplies account (0102053-530090); and

**WHEREAS**, Ordinance 2018-131 was approved authorizing expenditures not to exceed \$77,000 for the purchase of bulk road salt up to 1,200 tons (100%) of the contract quantity at a cost of \$64.14 per ton; and

**WHEREAS**, said contract allows for the Village to purchase up to 150% (1,800 tons) of the 1,200 tons at an increased cost of \$69.14 per ton between 120% and 150%; and

**WHEREAS**, staff has had to purchase a total of 1,600 tons of bulk road salt during the 2018-19 Fiscal Year to maintain an adequate amount to be available on-site for the duration of the 2018-19 Winter season and the start of the upcoming 2019-20 season; and

**WHEREAS**, additional funds are available within the Public Works Contractual Street Services account (0102040-520630) to be transferred into the Public Works Street Maintenance Supplies account (0102053-530090) to cover said expenditures; and

**WHEREAS**, all purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to transfer \$27,000 from budget account (0102040-520630) to account (0102053-530090); and

The Finance Director is hereby authorized to increase FY2019 purchase order number 1352 to Morton Salt Inc. from \$77,000 to \$104,000; and

The Finance Director is hereby authorized to make payment to Morton Salt Inc. in an amount not to exceed \$104,000 within the 2018-19 Fiscal Year.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2019-041.

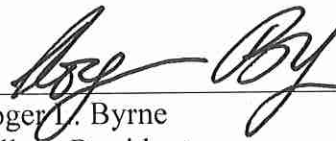
