AN ORDINANCE AMENDING ORDINANCE 2019-115 AUTHORIZING THE FINANCE DIRECTOR TO AMEND THE FY2018/19 MELLODY FARM TAX INCREMENT FUND BUDGET BY AN ADDITIONAL \$548,000 FOR THE REIMBURSEMENT OF CONSTRUCTION PAYMENTS FOR THE MELLODY FARM TAX INCREMENT PROJECT

WHEREAS, Bond Ordinance number 2017-065 provided \$20,000,000 for the reimbursement of construction payments for the Melody Farm Tax Increment Project; and

WHEREAS, Ordinance number 2019-115 authorized the FY2018-2019 budget to be amended by \$3,060,325; and

WHEREAS, the amended amount should have been \$3,608,325; and

WHEREAS, Budget Ordinance number 2018-071 needs to be amended to provide for this budgetary authorization.

NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS: THAT the Finance Director/Treasurer is authorized to increase the FY2018/19 Melody Farm Tax Increment District Fund budget by an additional \$548,000 to provide for the expenses of the project in FY2018/19.






