**AN ORDINANCE AUTHORIZING A FIRST YEAR CONTRACT RENEWAL
FOR THE 2020 SIDEWALK & CURB REHABILITATION PROGRAM
CONTRACT TO SCHROEDER & SCHROEDER INC. FOR AN AMOUNT NOT
TO EXCEED \$50,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of ways (ROW's) including public sidewalks and curbs; and

WHEREAS, to do so efficiently and effectively, the Village contracts out sidewalk rehabilitation services to remove and replace sections of sidewalk and curb & gutter that qualify as trip hazards; and

WHEREAS, the Village participated in the 2019 Municipal Partnering Initiative Concrete Flatwork Joint Bid; with Schroeder & Schroeder, Inc. being awarded the bid; and

WHEREAS, this ordinance authorizes a first year renewal with Schroeder & Schroeder, Inc. to perform said services; and

WHEREAS, \$50,000 is available within the FY2021 budget account (0209096-550050) for said work; and

WHEREAS, expenditures over \$25,000 require Village Board approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for the 2020 Sidewalk & Curb Rehabilitation Program with Schroeder & Schroeder, Inc. at a price not to exceed \$50,000 within the 2021 Fiscal Year.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Schroeder & Schroeder, Inc. an amount not to exceed \$50,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-045.






