ORDINANCE 2020-047

AN ORDINANCE WAIVING THE COMPETITIVE BIDDING PROCESS AND AUTHORIZING THE APPROVAL OF A CONTRACT WITH CHICAGOLAND PAVING CONTRACTORS, INC. TO EXTEND AND REPAIR THE VHAC ASPHALT PATH SURROUNDING THE NEWLY INSTALLED SPORTS TURF FIELDS FOR AN AMOUNT NOT TO EXCEED \$35,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of ways (ROW's); including public streets and paths; and

WHEREAS, with the newly installed Sports Turf at the Vernon Hills Athletic Fields (VHAC), the existing asphalt paths surrounding these fields need to be extended to reach the entrance of fields 10-12, and some resurfacing due to wear and tear during construction and the relocation of the existing storm sewer; and

WHEREAS, Chicagoland Paving Contractors, Inc. has provided staff with a proposal for said work for an amount of \$23,750; and

WHEREAS, due to the specialization of work and favorable pricing it is desirable to waive competitive bidding and award this project to Chicagoland Paving Contractors, Inc.; and

WHEREAS, Chicagoland Paving Contractors, Inc. has performed like work for the Village in the past, and has met staff's expectations in the previous contract years; and

WHEREAS, funds are available within FY2020 budget account (0209114-550030) to perform said work; with a contingency of an additional \$11,250 for extra materials needed based on the extent of damage; and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents with Chicagoland Paving Contractors, Inc. for the VHAC asphalt path extension and repairs for a price not to exceed \$35,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Chicagoland Paving Contractors, Inc. in an amount not to exceed \$35,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-047.






