**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO COUNTRYSIDE
FIRE PROTECTION DISTRICT FOR REIMBURSEMENT OF SALARIES ASSOCIATED
WITH PROVIDING DISPATCH SERVICES TO THE VILLAGE OF LIBERTYVILLE DURING
THE VILLAGE OF VERNON HILLS' FISCAL YEAR 2020/2021 IN AN AMOUNT NOT TO
EXCEED \$245,750**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village and Countryside Fire Protection District operate a joint-dispatch center; and

WHEREAS, the Village and Countryside Fire Protection District have entered into a contractual agreement with the Village of Libertyville to provide police and fire dispatch services; and

WHEREAS, the addition of fire dispatch personnel is part of those operating costs; and

WHEREAS, the Fiscal Year 2020/2021 budget includes \$245,750 in account 0803032-520540 available for this purpose; and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Countryside Fire Protection District for salary reimbursement during Fiscal Year 2020/2021 in an amount not to exceed \$245,750.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-056.


