AN ORDINANCE AUTHORIZING A SECOND YEAR RENEWAL FOR AQUATIC WEED AND ALGAE CONTROL SERVICES OF VARIOUS PONDS WITH CLARKE AQUATIC SERVICES, INC. FOR AN AMOUNT NOT TO EXCEED \$33,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village currently budgets funds within budget account (0102047-520600) to provide algae control services to thirty (30) Village maintained pond locations; and

WHEREAS, White Deer Run has agreed to contribute \$4,800 towards treatment costs for ponds of concern adjacent to their property; and

WHEREAS, Ordinance 2018-045 awarded a multi-year contract for said services with Clarke Aquatic Services, Inc. at a fixed rate for three years; with the option to renew the three-year contract two additional years for a total of five (5) years; and

WHEREAS, an additional \$1,515 above the base price of \$31,485 is budgeted for any additional services; and

WHEREAS, Clarke Aquatic Services, Inc. has provided the Village aquatic weed and algae control services for the past several years, and is very familiar with the scope of work and has done satisfactory work; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for aquatic weed and algae control services of Village ponds with Clarke Aquatic Services, Inc. at a price not to exceed \$33,000 for FY2021.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Clarke Aquatic Services, Inc. in an amount not to exceed \$33,000 for said services for FY2021.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-040.


