ADJUSTING THE CURRENT WAGES OF CERTAIN NON-UNION POSITIONS OF THE
VILLAGE OF VERNON HILLS**

WHEREAS, the President and Board of Trustees of the Village of Vernon Hills (the "Village") approved Ordinance Number 2020-060, April 21, 2020, entitled, "AN ORDINANCE ADJUSTING THE CURRENT WAGES OF CERTAIN NON-UNION POSITIONS OF THE VILLAGE OF VERNON HILLS" (hereinafter "Ordinance No. 2020-060"); and

WHEREAS, Ordinance No. 2020-060, in its attachment, contained a table of various salary steps and grades of employees, with associated salary amounts; and

WHEREAS, in the attachment, "Step 6" of "Grade 4" of the table contained an incorrect amount of \$97,211, when said amount should have read \$67,211.

WHEREAS, it is in the best interests of the Village to correct said scrivener's error.

BE IT ORDAINED by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois in the exercise of their home rule authority, as follows

SECTION 1: That Ordinance No. 2020-060 is hereby amended by correcting the following scrivener's error as contained therein:

In the attachment to the ordinance, "Step 6" of "Grade 4" of the table that reads "\$97,211" is hereby revised to read "\$67,211."

SECTION 2: That all other provisions of Ordinance No. 2020-060, approved April 21, 2020, not corrected hereby, shall remain in full force and effect.

SECTION 3: That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.

SECTION 4: This Ordinance shall be known as Ordinance Number 2020-075.


