**AN ORDINANCE TO ADJUST THE CURRENT SENIOR STAFF SALARIES IN
THE VILLAGE OF VERNON HILLS PAY PLAN**

WHEREAS, the Village of Vernon Hills Pay Plan ("*Pay Plan*") lists the corresponding salary ranges and salaries that are authorized for Senior Staff is periodically reviewed to assess the compensation for Village employees; and

WHEREAS, the Village Board desires to establish certain ranges for the Senior Staff and Police Commanders, which includes the following Pay Plan:

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2020-081.




