**AN ORDINANCE AUTHORIZING PAYMENT TO VERIZON WIRELESS FOR THE  
PURCHASE OF CELLULAR TELEPHONE SERVICES IN AN AMOUNT NOT TO  
EXCEED \$56,515**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Administration, Community Development, Public Works and Police Departments must maintain cellular services for their department employees; and

**WHEREAS**, Verizon Wireless has been determined by the Village to be beneficial to the Village as a supplier of cellular services for the Village of Vernon Hills; and

**WHEREAS**, all purchases over \$25,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS**, as follows:

**SECTION 1: EXECUTION OF PAYMENT.** The Village Manager is hereby authorized to execute all required documents to purchase cellular services from Verizon Wireless at an amount not to exceed \$56,515.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT.** The Finance Director is hereby authorized to make payment to Verizon Wireless during Fiscal Year 2020–2021 in an amount not to exceed \$56,515.

**SECTION 3: EFFECTIVE DATE.** This Ordinance shall be in full force and effect upon its passage and approval by a majority of the members of the Village Board.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2020-097
