ORDINANCE 2020-108

AN ORDINANCE AMENDING THE ANNUAL BUDGET OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE, STATE OF ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2020 AND ENDING APRIL 30, 2021

WHEREAS, by Ordinance No. 2020-050, the Village President and Board of Trustees of the Village of Vernon Hills ("Village Board"), Illinois adopted the Annual Budget of the Village of Vernon Hills for the fiscal year beginning May 1, 2020, and ending April 30, 2021; and

WHEREAS, subsequent to adoption of Ordinance 2020-050, the Village Board has determined the need to replace the HVAC system at Village Hall and as well as the range ventilation system at the Police Department building; and

WHEREAS, for these capital projects herein, a budget addition is required in the Capital Fund Village Hall Acquis/Construction and Police Building Remodeling as well as a budget transfer from the General Fund General Purpose Transfer to Capital FD to the Capital Fund Payment from General Fund and

WHEREAS, the Village Board has determined that it will serve and be in the best interest of the Village to adopt an Ordinance amending the Annual Budget.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF VERNON HILLS, LAKE COUNTY, ILLINOIS, as follows:

SECTION 1: RECITALS. The foregoing recitals are incorporated into, and made a part of, this Ordinance as the findings of the Village Board.

SECTION 2: ADOPTION OF AMENDMENTS. The Annual Budget shall be, and is hereby, amended to read as follows:

Table with 4 columns: EXPENDITURES - General Fund, ORIGINAL, AMENDMENT, REVISED. Rows include General Purpose 0109109 and Transfer to Capital FD 580095.

Table with 4 columns: Revenues - Capital Fund, ORIGINAL, AMENDMENT, REVISED. Rows include Fund Revenues 02 and Payment From General Fund 499994.

Table with 4 columns: EXPENDITURES - Capital Fund, ORIGINAL, AMENDMENT, REVISED. Rows include Village Hall Acquis/Cons 0209049-550030 and Police Building Remodeling 0209097-550040.

SECTION 3: PUBLICATION. The Village Clerk is hereby directed to publish this Ordinance in pamphlet form pursuant to the Statutes of the State of Illinois.

SECTION 4: EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner as provided by law.

SECTION 5: ORDINANCE NUMBER. This Ordinance shall be known as Ordinance Number 2020-108.


