

RESOLUTION 2012-022

A RESOLUTION AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND EXTEND THE EXISTING CONTRACT WITH BEST SANITATION SERVICES FOR SUPPLYING AND SERVICING PORTABLE TOILET UNITS DURING FY2012 AND FY2013 AT THE VERNON HILLS ATHLETIC COMPLEX, VERNON HILLS GOLF COURSE, JULY FOURTH CELEBRATION, SUMMER CELEBRATION, OKTOBERFEST CELEBRATION, AND HOLIDAY LIGHT SHOW IN AN AMOUNT NOT TO EXCEED \$15,000

WHEREAS, the Vernon Hills Public Works Department seeks outside entities to supply and service portable toilet units for the Vernon Hills Athletic Complex, Vernon Hills Golf Course, July Fourth Celebration, Summer Celebration, Oktoberfest Celebration, and the Holiday Light Show; and

WHEREAS, Best Sanitation Services has provided this service for the Village since 2010 with no increase to cost; and

WHEREAS, Best Sanitation Services has submitted a proposal to extend their existing contract for two additional years; and

WHEREAS, the cost for FY2012 will remain the same at \$10,676; plus the cost for additional services as needed, and a 3% cost increase will be applied for FY2013; and

WHEREAS, Public Works staff is familiar and pleased with the services that Best Sanitation Services has provided.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Manager is authorized to sign an extended contract agreement with Best Sanitation Services to supply and service portable toilet units for FY2012 and FY2013 at the Vernon Hills Athletic Complex, Vernon Hills Golf Course, July Fourth Celebration, Summer Celebration, Oktoberfest Celebration, and the Holiday Light Show; and

THAT, the Finance Director is authorized to make payments to Best Sanitation Services in an amount not to exceed \$15,000 during each fiscal year.
