

RESOLUTION 2012-047

A RESOLUTION AUTHORIZING APPROVAL OF EXPENDITURES FOR ENVIRONMENTAL MOSQUITO MANAGEMENT SERVICES TO BE PAID TO CLARKE MOSQUITO MANAGEMENT, INC. WITHIN THE 2012/2013 BUDGET YEAR FOR A TOTAL AMOUNT NOT TO EXCEED \$57,210

WHEREAS, the Village of Vernon Hills entered into an agreement on January 20, 2004 with Clarke Mosquito Management, Inc. for the Village of Vernon Hills Environmental Mosquito Management Program; and

WHEREAS, the Village Board has approved the 2012/2013 budget that delineates \$57,210 for insect control services under account 0102040-520610; and

WHEREAS, Clarke Mosquito has agreed to hold the cost of mosquito control services from year 2010 through year 2012 with no increase to cost; and

WHEREAS, the base cost for the 2012 Environmental Mosquito Management Program is \$54,810; and

WHEREAS, Surveillance and Monitoring; including one New Jersey light trap and one oviposition or gravid trap is included in the cost; and

WHEREAS, larval control includes three inspections of 129 sites, six targeted inspections of 64 sites, and three Culex targeted inspections of 37 sites, and four treatments of 2400 catch basins; and

WHEREAS, the cost for 2012 Ultra Low Volume (ULV) Treatments using Mosquitomist, four (4) community wide, July 4th, and the Summer Celebration is included in the above cost; and

WHEREAS, the cost for an additional community wide ULV Treatment will be billed at \$4,900; and

WHEREAS, the ULV treatment cost for Arbortheater events and other special events is estimated at \$200 per special event.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Village Manager and Finance Director are authorized to execute payments to Clarke Mosquito Management, Inc. for the Village of Vernon Hills 2012 Environmental Mosquito Management Program in an amount not to exceed \$57,210.




