**AN ORDINANCE AUTHORIZING APPROVAL TO EXPEND FUNDS FROM THE
DUI FUND FOR THE PURPOSES OF EQUIPMENT ACQUISITION NOT TO
EXCEED \$3,795**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills maintains a Driving Under the Influence (DUI) Fund, from which funds are used for the purposes of funding activities and equipment related to enforcement of DUI laws; and

WHEREAS, the need for this equipment was unforeseen and therefore not included in the current FY20-21 budget; and

WHEREAS, a payment from DUI Fund Account #1709109 540050 in the amount of \$3,795 is requested for the procurement of an Alco-Sensor VXL POA Illinois Set; and

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:

The Finance Director is hereby authorized to release \$3,795 from DUI Fund Account #1709109 540050.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2021-048.


