WHEREAS, the Village Board has determined that the following vendors are well suited for providing legal services to the Village:

Klein, Thorpe and Jenkins, Ltd. for Village Attorney services
Winer & Winer for prosecuting legal services,
Storino, Ramello & Durkin for legal services for labor issues,
Morrill & Fiedler LLC for government legal issues,
Hunt and Associates for special legal services,
Law Offices of Henry Tonigan for adjudication services; and

WHEREAS, all professional service engagements, which require the expenditure of over \$25,000, require Board of Trustee approval; and

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD
OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS,
AS FOLLOWS:**

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Village Manager is authorized to execute contracts to commit the Village to make payments to:

Klein, Thorpe and Jenkins, Ltd. in the amount of \$200,000
Winer & Winer in the amount of \$75,000
Morrill & Fiedler LLC in the amount of \$54,000
Storino, Ramello & Durkin in the amount of \$50,000
Hunt and Associates in the amount of \$50,000
Law Offices of Henry Tonigan in the amount of \$20,000

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ALL PRIOR ORDINANCES SUPERSEDED: This Ordinance shall supersede all prior ordinances passed by the Village of Vernon Hills with regard to these specific expenditures, including Ordinance Number 2020-061, passed on May 5, 2020.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2021-050.


