**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$25,000 FOR THE PURCHASE OF MISC. BUILDING MAINTENANCE SUPPLIES, HOLIDAY LIGHTING AND STREET LIGHTING SUPPLIES AND SERVICES FROM STEINER ELECTRIC COMPANY THROUGHOUT THE FY2022 BUDGET YEAR NOT TO EXCEED \$155,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Steiner Electric Company is a beneficial local source to the Village as a supplier of electrical supplies and misc. parts purchased for general building maintenance and street lighting work; and

**WHEREAS**, the Village Board approved the FY2022 budget which delineates electrical supplies in the following accounts:

**WHEREAS**, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is authorized to execute payments to Steiner Electric Company for the purchase of electrical supplies, misc. general building maintenance parts, holiday lighting, and street lighting supplies and services throughout the FY2022 budget year in an amount not to exceed \$155,000; and

THAT, the Finance Director is authorized to apply reimbursement monies received from accidental light pole knockdowns to account (0101005-520728), and

THAT, the Finance Director is authorized to increase the FY2022 purchase order to Steiner Electric Company for the purchase of street light poles and fixtures as needed with said reimbursements.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2021-057.






