WHEREAS, all professional service engagements, which require the expenditure of over \$25,000, require Board of Trustee approval; and

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:




