AN ORDINANCE AUTHORIZING THE APPROVAL OF A CONTRACT WITH CORRECTIVE ASPHALT MATERIALS, LLC (CAM) TO APPLY RECLAMITE MALTENE BASED REJUVENATING AGENT ON VILLAGE STREETS FOR AN AMOUNT NOT TO EXCEED \$45,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village budgeted \$55,000 within account (0209059-550050) for contractual Reclamite preservation sealing of Village streets within the FY2022 budget; and

WHEREAS, the Village participated in the Village of Winnetka’s MPI Joint Bid for Pavement Rejuvenation; with Corrective Asphalt Materials, LLC (CAM) providing the lowest and only qualifying bid which is renewable up to two additional years; and

WHEREAS, the scope of work performed by CAM will include applying Reclamite Maltene-Based Rejuvenating Agent for the preservation of newly paved streets within the previous 2020 Road Rehabilitation area as indicated below; and

WHEREAS, CAM will be responsible for the furnishing and application of the Reclamite and CRF materials, furnishing and placement of lime screenings, all traffic control and signage, handling of complaints and issues, and street sweeping post application; and

WHEREAS, Corrective Asphalt Materials, LLC has provided this service to the Village previously, and satisfactory; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for contractual Reclamite preservation sealing of Village streets with Corrective Asphalt Materials, LLC at a price not to exceed \$45,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Corrective Asphalt Materials, LLC in an amount not to exceed \$45,000 within the 2022 Fiscal Year for said services.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2021-067.




