AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO TYLER TECHNOLOGIES FOR THE PURCHASE OF NEW WORLD PUBLIC SAFETY, BRAZOS ECITATION, AND INCODE COURT ANNUAL MAINTENANCE AGREEMENTS IN A COMBINED AMOUNT NOT TO EXCEED \$194,500.00

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village entered into an agreement to provide contract dispatch services to the Village of Libertyville; and

WHEREAS, the Village utilizes Tyler New World Public Safety for computer-aided dispatching, records management, and field reporting at an annual support cost of \$185,000.00; and

WHEREAS, the Village utilizes Brazos eCitation for ticket writing at an annual support cost of \$5,600.00; and

WHEREAS, the Village utilizes Incode Court for adjudication hearings at an annual support cost of \$3,900.00; and

WHEREAS, Tyler New World Public Safety and Brazos are utilized by both agencies, and an annual service maintenance agreement sourced solely from Tyler Technologies is required for use under the Village license agreement; and

WHEREAS, the Village collects an annual fee from the Village of Libertyville to offset their portion of the expenses; and

WHEREAS, funds were designated and are available in the FY2021/2022 budget; and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to purchase the annual software maintenance agreement from Tyler Technologies at a price not to exceed \$194,500.00.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Tyler Technologies in a combined amount not to exceed \$194,500.00.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2021-082.


