AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO KEMPER SPORTS MANAGEMENT FOR THE PAYMENT OF SALARIES AND BENEFITS OF THE VERNON HILLS GOLF COURSE FOR FISCAL YEAR 2021/2022 IN AN AMOUNT NOT TO EXCEED \$235,227

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village has engaged Kemper Sports Management, Inc. to manage the Vernon Hills Golf Course; and

WHEREAS, the Village, as part of the management contract terms is responsible for reimbursing Kemper Sports Management, Inc. for the salary and benefits paid to the employees of the Vernon Hills Golf Course; and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Kemper Sports Management Inc. for Vernon Hills Golf Course employee salaries and benefits for Fiscal Year 2021/2022 in an amount not to exceed \$235,227 and is further authorized to immediately release payments to Kemper Sports Management for Fiscal Year 2021/2022 bi-weekly salary and benefit costs prior to appearing on the invoice approval list.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2021-077.


