

ORDINANCE 2021-092**

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO CURRIE MOTORS FOR THE PURCHASE OF ONE (1) 2021 FORD UTILITY INTERCEPTOR IN AN AMOUNT NOT TO EXCEED \$35,172

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, funds are delineated within FY2021-2022 budget account (2103030-540020) for vehicle purchases; and

WHEREAS, Ordinance 2021-092 authorizes the purchase of one (1) 2021 Ford Utility Interceptor for an amount not to exceed \$35,172 through Currie Motors; and

WHEREAS, Currie Motors, 10125 W. Laraway Road, Frankfort, Illinois 60423 is an authorized Ford dealership that has been selected through a competitive bidding process to provide motor vehicles to municipalities participating in the Northwest Municipal Conference Suburban Purchasing Cooperative Contract #152 at the rate specified in the bid (contract); and

WHEREAS, the insurance monies for the unexpected loss of two police vehicles will provide funds for the requested purchase of said vehicle; and

WHEREAS, all purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Currie Motors to commit the Village to purchase one (1) 2021 Ford Utility Interceptor in an amount not to exceed \$35,172; and

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Currie Motors in an amount not to exceed \$35,172 for the purchase of one 2021 Ford Utility Interceptor; and

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as Ordinance Number 2021-092.


