**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO NAPLETON FORD FOR THE PURCHASE OF ONE (1) 2021 FORD EDGE IN AN AMOUNT NOT TO EXCEED \$34,214.24**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, funds are delineated within FY2021-2022 budget account (2103030-540020) for replacement vehicle purchases; and

**WHEREAS**, Ordinance 2021-093 authorizes the purchase of one (1) 2021 Ford Edge; and

**WHEREAS**, staff sought quotes from three reputable Ford dealerships for said purchase; and

**WHEREAS**, Napleton Ford, 1010 S Milwaukee Ave, Libertyville, IL 60048 provided the lowest quote amongst the three dealerships; and

Napleton Ford -	\$34,214.24
Currie Motors -	\$36,430.00
Highland Park Ford -	\$37,930.00

**WHEREAS**, all purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Napleton Ford to commit the Village to purchase one (1) 2021 Ford Edge in an amount not to exceed of \$34,214.24; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Napleton Ford in the amount of \$34,214.24; and

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as Ordinance Number 2021-093.


