

RESOLUTION 2012-083

**A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT  
BETWEEN THE VILLAGE OF VERNON HILLS AND THE VILLAGE OF LAKE BLUFF FOR THE  
PURPOSE OF REIMBURSING THE VILLAGE OF VERNON HILLS FOR A SHARE OF  
THE COST OF A T-1 DATA LINE**

WHEREAS, Article VII, Section 10, Of the 1970 Constitution of the State of Illinois, and 5 ILCS 220/1 et seq, of the Illinois Compiled Statutes, (1989), authorize and encourage intergovernmental cooperation; and

WHEREAS, the Village of Vernon Hills ("Vernon Hills") and the Village of Lake Bluff ("Lake Bluff") desire to enter into an agreement pursuant to the Intergovernmental Cooperation provisions of Article VII, Section 10 of the 1970 Illinois Constitution and the Intergovernmental Cooperation Act, 5 ILCS 220/1, et seq.; and

WHEREAS, Vernon Hills has been paying the full monthly cost for the use of a T-1 digital data line for access to the Law Enforcement Agencies Data System ("LEADS") network and the T-1 line is capable of use by several municipalities at once; and

WHEREAS, Lake Bluff has implemented a LiveScan digital fingerprinting system that requires connectivity to the State of Illinois and Lake Bluff will benefit from the use of a shared T-1 line for its LiveScan and LEADS network access at a cost of \$286 (two hundred eighty six dollars) per month; and

WHEREAS, the Board of Trustees has determined that the approval and execution of the Agreement is in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED** by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois:

Section 1. Recitals.

The foregoing recitals are incorporated herein as findings of the President and Board of Trustees.

Section 2. Approval of License Agreement.

The Agreement between the Village of Vernon Hills and the Village of Lake Bluff is hereby approved in substantially the form attached as Exhibit A.

Section 3. Execution of License Agreement.

The Village President and the Village Clerk are authorized and directed to execute and seal the Agreement, on behalf of the Village.

Section 4. Effective Date.

This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.




