

ORDINANCE 2021-140**

AN ORDINANCE AUTHORIZING PAYMENT TO THE VERNON HILLS PARK DISTRICT IN THE AMOUNT OF \$75,000 TOWARDS THE LASCHEN CENTER TENNIS COURT IMPROVEMENTS

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Resolution 2020-031 was approved by the Village Board on September 15, 2020 authorized the Village President to execute an Intergovernmental Lease Agreement with the Vernon Hills Park District; and

WHEREAS, the exhibit to this Resolution included an exhibit that included “Rehab Tennis Courts”; and

WHEREAS, Resolution 2020-031 was silent to a contribution, but in subsequent meetings including a Village-Park District Liaison meeting and during the budget process, the Village committed to assist in financing said work in the amount of \$75,000; and

WHEREAS, funds were then delineated in FY 2021-2022 budget account (0209049 550030) titled, “Tennis Court & Playground Contribution to Park District”; and

WHEREAS, the Vernon Hills Park District contracted to have the Laschen Center Tennis Courts fully removed and replaced including the fencing; and

WHEREAS, said work has been completed and the Vernon Hills Park District has invoiced the Village for the agreed upon contribution; and

WHEREAS, the Village Board of Trustees agree regarding this commitment and payment; and

WHEREAS, all purchases over \$25,000 require Board of Trustee approval.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to the Vernon Hills Park District in the amount of \$75,000; and

SECTION 2: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 3: ORDINANCE NUMBER: This ordinance shall be known as ORDINANCE NUMBER 2021-140.


