

**VILLAGE OF VERNON HILLS  
ORDINANCE 2022-011**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO  
KEMPER SPORTS MANAGEMENT FOR PAYMENT OF THE 2021  
MANAGEMENT FEE FOR THE VERNON HILLS MUNICIPAL GOLF COURSE  
IN AN AMOUNT NOT TO EXCEED \$45,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village’s agreement with Kemper Sports Management (*“KSM”*) for the management of the Vernon Hills Municipal Golf Course stipulates that for fiscal year 2021 KSM shall receive \$45,000 for the management fee unless profits exceed \$170,000; and

**WHEREAS**, the operating profits for the Vernon Hills Municipal Golf Course for fiscal year 2021 did not exceed \$170,000; and

**WHEREAS**, the fiscal year 2021 KSM management fee to be paid to KSM is \$45,000; and

**WHEREAS**, expenditures over \$25,000 require Board of Trustee approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Kemper Sports Management in an amount not to exceed \$45,000 for the fiscal year 2021 management fee and is further authorized to immediately release payment to Kemper Sports Management for the management fee prior to appearing on the invoice approval list.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2022-011.






