ORDINANCE 2022-037**

**AN ORDINANCE AUTHORIZING A THIRD YEAR CONTRACT RENEWAL
WITH SCHROEDER & SCHROEDER INC. FOR THE 2022 SIDEWALK &
CURB CONCRETE REHABILITATION PROGRAM FOR AN AMOUNT NOT
TO EXCEED \$115,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of ways (ROW's) including public sidewalks and curbs; and

WHEREAS, to do so efficiently and effectively, the Village contracts out sidewalk rehabilitation services to remove and replace sections of concrete sidewalk and curb & gutter that qualify as trip hazards; and

WHEREAS, the Village participated in the 2019 Municipal Partnering Initiative Concrete Flatwork Joint Bid; with Schroeder & Schroeder, Inc. being awarded a multi-year bid; and

WHEREAS, this ordinance authorizes a third year renewal with Schroeder & Schroeder, Inc. to perform said services; and

WHEREAS, in addition to the scope of work for the Concrete Rehabilitation Program, staff is working to resolve drainage issues which requires removal and replacement of sidewalk sections to rectify the issue; and

WHEREAS, staff believes it would be beneficial for the Village to have the replacement of these sections of sidewalk performed by Schroeder & Schroeder at the same time they are performing the concrete work as part of the annual Concrete Rehabilitation Program’s scope of work; and

WHEREAS, \$80,000 is budgeted within FY2023 budget account (0209096-550050) for the annual concrete rehabilitation work, and \$35,000 is available within FY2023 budget account (0209111-550030) to replace sections of sidewalk required to make drainage improvements; and

WHEREAS, expenditures over \$25,000 require Village Board approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents for the 2022 Sidewalk & Curb Rehabilitation Program with Schroeder & Schroeder, Inc. for an amount not to exceed \$115,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Schroeder & Schroeder, Inc. for an amount not to exceed \$115,000 with Fiscal Year 2023.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-037.




