

**VILLAGE OF VERNON HILLS
ORDINANCE 2022-035**

AN ORDINANCE AUTHORIZING A FIRST YEAR RENEWAL WITH TKG ENVIRONMENTAL SERVICES GROUP FOR CONTRACTUAL STREET SWEEPING SERVICES FOR AN AMOUNT NOT TO EXCEED \$60,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village budgeted \$60,000 within Fiscal Year 2023 budget account (0102040-520630) for contractual sweeping of Village streets; and

WHEREAS, Ordinance 2021-033 was approved authorizing the Village to execute a contract with TKG Environmental Services Group, LLC for said services within Fiscal Year 2022; with the option to renew the contract up to two additional years for Fiscal Years 2023 & 2024; and

WHEREAS, said contract will be renewed for Fiscal Year 2023 at a base amount of \$58,587.43 which is a 3% increase from the previous year, and a contingency amount of \$1,412.57 will be available for any unanticipated services needed; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to renew the contract for contractual street sweeping of Village streets with TKG Environmental Services Group, LLC for an amount not to exceed \$60,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to TKG Environmental Services Group, LLC in an amount not to exceed \$60,000 within Fiscal Year 2023.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2022-035.




