

**VILLAGE OF VERNON HILLS  
ORDINANCE 2022-049**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES OVER \$25,000 TO LAKE COUNTY DEPARTMENT OF PUBLIC WORKS FOR WATER AND SEWER SERVICES WITHIN THE FY2023 BUDGET YEAR NOT TO EXCEED \$33,600**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Lake County Department of Public Works is considered a source to be beneficial to the Village as a supplier of water and sewer for the Village of Vernon Hills; and

**WHEREAS**, the Village Board approved the FY2023 budget, which delineates potable water/sewer/irrigation in the following Public Works Department accounts:

**WHEREAS**, all expenditures and purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is authorized to execute payments to Lake County Department of Public Works for water and sewer services throughout the FY2023 budget year in an amount not to exceed \$33,600.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2022-049.




