

RESOLUTION 2012-142

A RESOLUTION AMENDING RESOLUTION 2012-023 AUTHORIZING AN INCREASE IN PAYMENT TO SCHROEDER ASPHALT SERVICES FOR THE 2012-2013 BITUMINOUS PAVEMENT PATCHING PROGRAM FROM \$40,000 TO \$43,639.04

WHEREAS, the President and Board of Trustees desire to maintain the Village's infrastructure; and

WHEREAS, Schroeder Asphalt Services of Huntley, IL submitted the lowest qualified bid to perform Bituminous Pavement Patching of Village streets in FY2011-2012; and

WHEREAS, Resolution 2012-023 was approved on March 05, 2012 authorizing approval to renew the FY2011-2012 contract with Schroeder Asphalt Services for FY2012-2013 at a cost of \$39,552; with an additional \$448 available for unanticipated needs; and

WHEREAS, during the 2012-2013 program, an additional 124 square yards of unanticipated asphalt patching was performed outside of the proposed 1,200 square yards; causing the overall cost of the work to increase from \$39,552 to \$43,639.04; which exceeds the previously authorized \$40,000; and

WHEREAS, an authorization of an additional \$3,639.04 is needed in order to pay Schroeder Asphalt Services for the overall work they performed under the 2012-2013 Bituminous Pavement Patching Program; and

WHEREAS, \$30,000 remains available within the combined FY2012-2013 Preventative Street Maintenance Street Construction account 0209059-550050 to increase the purchase order to Schroeder Asphalt Services in the amount of \$3,639.04.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT, the Finance Director is authorized to increase FY2012-2013 purchase order #250 to Schroeder Asphalt Services, Inc. in the amount of \$3,639.04, and to make payment to Schroeder Asphalt Services in an amount not to exceed \$43,639.04 for all work performed during the 2012-2013 Bituminous Pavement Patching Program.


